

NEWSLETTER SUBSCRIPTION: USUAL ERRORS

Upon collection of personal data for direct marketing purposes, the person needs to give an active and separate consent and has to be informed about her right, including to oppose at anytime the use of her/his data for that purpose. So the notice is a bit longer.

So this is **not** sufficient:


